

## Boulder FY 2015-16 Student Fee Proposals

#### Course and Instructional Fees

- Four departments are converting from course to program fees at the same or reduced rates: ALTEC, Anthropology, Geography, and Psychology.
- Three departments request changes to their program fees for increased facility, equipment, supplies, and materials costs: Computer Science, Chemical and Biological Engineering, and Astrophysical and Planetary Sciences.
- o The Economics department requests elimination of course fees on three courses.
- The Geography department requests an increase to course fees on field courses, due to higher vehicle and travel costs.
- Three new program fees are requested to support equipment, supplies and programming in General Engineering Plus, Ethnic Studies, and French and Italian.

#### Student Activity Fees

- CUSG student activity fee Reduction of \$15.77 from moving student fee programs to Student Affairs; CUSG fee setting still in process.
- Wardenburg student health fee for anticipated expense increases.
- Mental Health (Counseling) fee for expanded counseling and mental health services for students.
- United Government of Graduate Students (UGGS) fee for professional development, advocacy, and events for graduate students.
- Housing and Dining Services proposed increase of 3.0% for inflationary increases, building operations and debt service.

## Colorado Springs Campus

- Program, Course and Instructional Fees
  - The College of Letters, Arts, and Sciences:
    - The department of Visual and Performing Arts is requesting two new program fees in Dance and Museum Studies & Gallery practice to cover the cost of consumable supplies and specific program expenditures.
    - VAPA and Foreign Language departments are requesting to add courses to existing approved program fees.
    - The Physics and Energy Science department requests an inflationary increase for maintaining laboratory supplies and equipment.
    - Economics requests a new program fee to support supplemental instruction.
    - Anthropology requests one new fee and one increase in an existing fee to cover costs of materials and supplies.
    - The college also requests to eliminate four existing course fees.

#### Student Activity Fees

- The Student Health Center is requesting a new fee for International Student Health Insurance. This hard waiver mandatory fee coincides with the Federal mandate that all international students maintain health insurance.
- A request to increase the existing Safety and Transportation Fee is due to significant increase in parking spaces and thus an increased need for security patrols. Two additional shuttles have been added to the fleet, increasing fuel, maintenance and payroll expenses. The original language that was voted on and passed by the student body allows for up to a 10% increase without a vote of the students.

#### Housing and Dining Services

 A housing fee increase will cover inflationary costs in utilities, food, and compensation as well as additional professional staff necessary to support the increased number of first year students living on campus.

## Anschutz Medical Campus FY 2015-16 Student Fee Proposals

- The School of Dental Medicine is eliminating its anatomical fee charged to first year students.
- The Child Health Associate/Physician Assistant program is eliminating existing program fees and will cover these costs through tuition. The program is adding a new Program Year 1 Anatomy Fee to cover just the anatomical costs incurred in students' first year.
- The Anesthesiology program is eliminating its Anatomical Course Fee. The
  program will cover these costs through tuition and will continue to evaluate the
  need for program fees as this is still a new program.
- The health insurance fees are still being negotiated; the "not to exceed amount" is a 15% increase to \$4,505.

## Denver Campus

#### **Program Fees in Schools and Colleges**

- The College of Arts and Media is increasing its fee for majors 8.6% to cover additional advising to increase availability to students.
- The College of Liberal Arts and Sciences is increasing its majors fee 3.9% to expand advising to students and its program fee 7% to cover chemistry lab coordination, Writing Center consultants, and computer lab resources.
- Bioengineering is eliminating its fee and including costs in a differential tuition rate.
- The School of Public Affairs is increasing its program fees 11%-15% to partially fund a student services coordinator.
- Four colleges are increasing program fees by the cost of inflation.
- The College of Engineering and Applied Science clarifies its majors fee covers career fairs, resources for certification exams, internship placements, and career networking events. Its instructional fee funds academic support for students, lab and field laboratory expenses, and student engagement and student success.

#### **Other Fees on Campus**

- The complex "matriculation fee" is being changed into a "New Student Fee." As part of a CU-wide initiative, transcripts will now be charged as they are ordered instead of a one-time lifetime fee.
- The Student Activities Fee is increasing \$1.70 or 7.0% to \$25.83 so Student Government can improve office function with a full time manager and fund student workers to improve academic liaison activities.
- A new charge will be applied to sponsors of international students. This is not a student fee, but \$100 per term will be charged to support the administrative costs of serving over 40 international sponsors.
- The International Student Health Insurance Fee is still being negotiated, not to exceed a 20% increase to \$2,763 per term.

#### **Student Services Fee**

This fee in increasing 29¢ or 2.7%. The Student Fee Review Committee closely reviews all requests across student services areas and many have already been denied or postponed. The supported components include:

- \$27,825 to expand college transition and retention initiatives and cultural programming.
- Auraria's Gay, Lesbian, Bisexual & Transgender services needs an assistant director to support the increasing number of students being served by the office. Approval is contingent upon funding availability from MSUD and CCD.
- Housing and Residential Education requires resources to address increasing needs of commuter students (96% of students at the Denver campus).
- The Peer Advocate Leader Program needs \$11,235 for on-campus peer mentors to address a 20% increase in the number of students served.

#### **Auraria Fees**

- The Auraria Bond Fee will increased by the cost of living if approved by the Auraria Board of Directors.
- The Auraria Higher Education Center is proposing a new Student Facilities Fee of \$5.00 per term to support the Tivoli Park, student coffee lounge and patio, and other student space amenities. The proposed new fee will first fund the construction of Phase II of the Tivoli Park project estimated at \$4.3 million. Student referendum will be held in April 2015.
- The RTD Fee is increased to cover the fixed dollar amount (which is not increasing) spread across declining Auraria enrollment. The increase is \$8.00 to \$97.00 which is supported by the Student Advisory Committee to the Auraria Board. Although the percent increase is high, this is still the best RTD package students can access.
